Northern Star Scouting Venturing Officers Association:

A Venturing Officers Association (VOA) is a team of youth Venturers, supported by adult Advisors, that provide support and guidance for the Venturing program. The Northern Star Scouting VOA works with Venturing Crews and Venturers within the council to provide training for Venturers and Advisors, program and events for Venturing Crews, and monthly Venturing forums to bring together Venturers and Advisors from around the council.

Officer Positions:

A Venturing Officers Association has four officer positions: President, Vice President of Administration, Vice President of Communications, and Vice President of Program.

Qualifications:

To be an officer in the Northern Star Scouting Venturing Officers Association, you must be registered as a Venturer in Northern Star Scouting and under the age of 21 for the entirety of the term of office.

Term of Office:

From June 1, 2024 through May 31, 2025.

Application Process:

To apply to be an officer, complete the biographic information on the following page, select the positions for which you are applying, read and sign the Applicant's Agreement, obtain your Crew Advisor's signature, and obtain a parent's signature if you are under the age of 18. The Council Approval will be obtained after your submission.
